

### Larry Brendel, TANF Regional Program Manager, U.S. Department of Health and Human Services, Administration for Children and Families. Office of Family Assistance, Region VI

Larry Brendel began his public service career with the Illinois Division of Vocational Rehabilitation, Disability Determination Services in July 1971 and subsequently began working as a Federal employee in April 1977 in Chicago. In August 1977, Mr. Brendel made the move to the Dallas Regional Office, working as a program analyst for the Social Security Administration's Disability Program. He began working for the Office of Family Assistance in July 1980 serving in various positions with the AFDC, JOBS, and Child Support Enforcement programs. He is currently a Program Manager of the Temporary Assistance for Needy Families (TANF) program within the Administration of Children and Families, Office of Family Assistance, Region VI.
