- **Second Funding Phase: 2020 - 2025**
- **Strategic Priority Focus of First Phase: Systemic Change/
Client Centered**
- **Strategic Priority Focus of Second Phase: Systemic Change/
Sustainability**

First Funding Phase: Strategic Goals & Outcome

- Needs Assessment and Gap Analysis to Identify Administrative and Programmatic Needs
 - **Findings:** Programs were working in silos with children and adult focus that was partially coordinated
 - **Outcome:** Developed a coordination measure instrument and trained staff to improve client outcomes to involve joint service planning and service plan implementation.



Second Funding Phase: Strategic Goal & Outcome (Sustainability Focus)

- Imbed tribal TANF and child welfare systemic coordination/integration goal through structures, including:
 1. Social Services Division Organizational Chart (prevention/intervention based)
 2. Revision/articulation of Division System of Care
 3. Data Collection Platform (Eaglesun/ Tribal Assistance)
 4. Title IVE/B Tribal Family First Plan



Social Services Division System of Care Conceptual Framework Description

Model Rationale: This Social Services Division System of Care reflects the overarching picture of the Adult and Children services outcomes that are intended for children, adults, elders, and families. The results include outcomes that will prepare the customers for lifetime learning with cultural and other toolkit for success. The supports we provide together include culture as a protective factor, workforce development, safe havens of care, engagement, and leadership development.

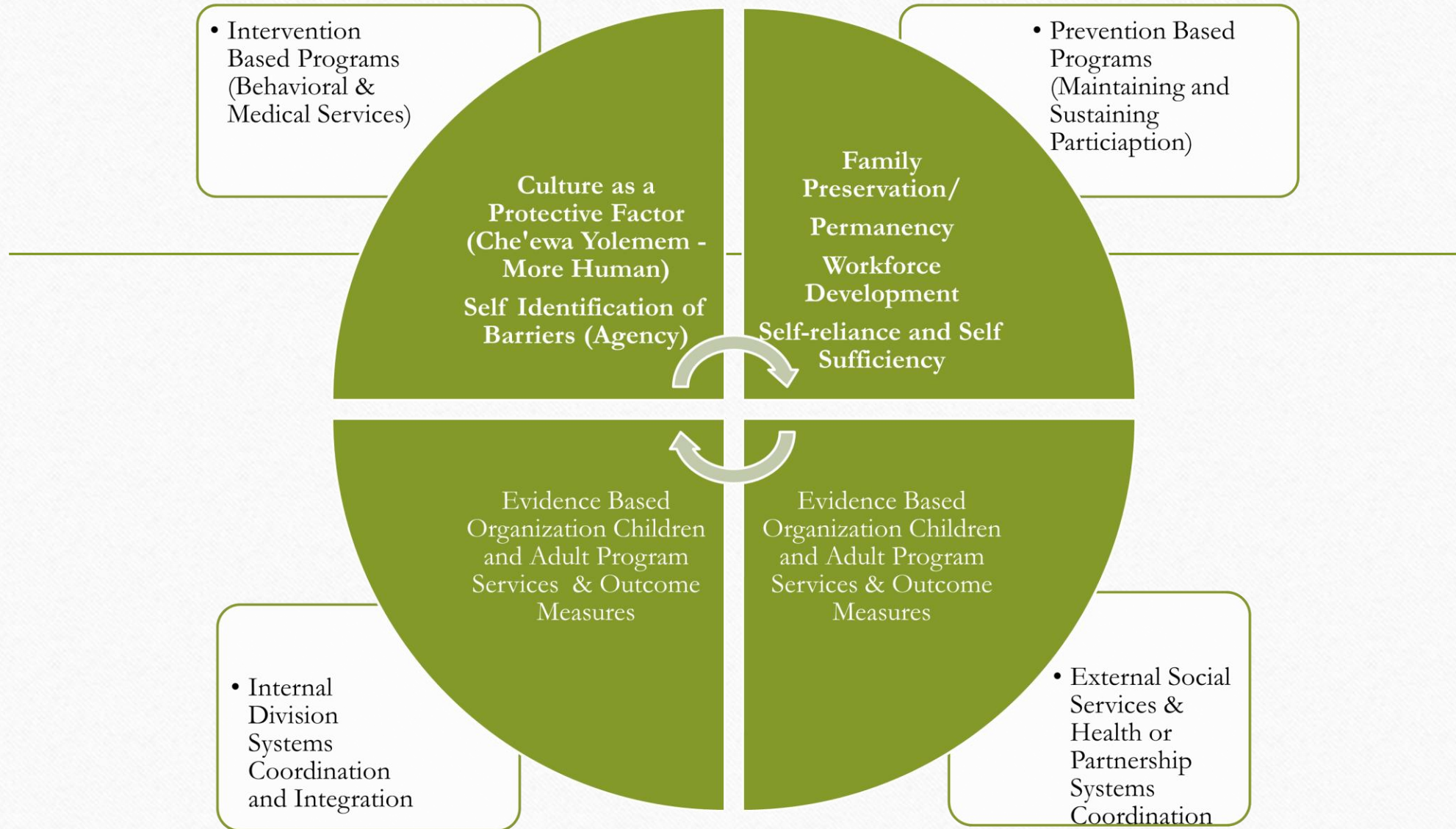
Quadrant 1: Using culture as a foundation, the Division helps clients to navigate our System of Care in a culturally responsive array of services in which helpers engage clients to become self-reliant and self-sufficient.

Quadrant 2: We assist families to maintain and sustain positive engagements in lifelong learning programs services involving personal growth to achieve stability and sustainable income.

Quadrant 3: The System of Care is designed to operate with visible outcomes that make a difference in the lives of families in their bid for self-reliance and self-sufficiency.

Quadrant 4: The partnerships with the Health Department, as well as with educational institutions facilitate wellbeing, prevent disease, and promote lifetime learning resources and toolkits for success.

Next Steps: Review of Program Logic Model & Self-Assessment to Match Newly Articulated System of Care

Strategic Goals and Outcomes:

1. Revise and adapt program logic model to improve from service coordination outcomes model to service integration outcomes model
2. Design and implement self-assessment process to achieve continuous improvement of integrated system of care
3. Continue to implement culturally responsive programming to sustain model with a focus on facilitating cultural training as a protective factor and use data platform to implement data-based decision making approach.
