Navigating Child Care Relief Funding Processes

This brief is for Lead Agencies and provides considerations and tips for working with key decisionmakers at the legislative, executive, or Tribal leadership levels for American Rescue Plan Act budget authorization. It also provides guidance for navigating the agency planning, budget, and procurement processes for efficient and time-sensitive disbursement of funds.

Strengthening Stabilization Grant Integrity with Internal Controls

The brief and the Child Care Stabilization Grantee Internal Controls Self-Assessment were developed to guide Lead Agencies in reviewing and evaluating their internal controls for the childcare stabilization grant program. The brief provides strategy considerations for Lead Agencies on how to leverage existing and create new program integrity policies and processes. The self-assessment instrument allows agencies to self-evaluate, prioritize, and monitor risk areas in their policies and processes to assure compliance with the American Rescue Plan (ARP) Act of 2021.

Family Child Care Expense Tracking Tool

This tracking tool, by First Children's Finance, is designed to be adapted by states, territories, and Tribes to align with the grants they award, or it may be shared with providers to adapt to their needs. It lists all possible categories of expenditures and provides a tool for tracking expenditures for a 12-month period. It is available as an Excel file and a PDF.

Child Care Stabilization Grant Communication Toolkits

For childcare stabilization grant funds to stabilize the childcare sector, eligible childcare providers need to learn about, apply for, and access these critical funds. As such, effective, timely communication is essential.

These resources were designed to help states, territories, and Tribes develop effective, coordinated communication strategies and concise messages that will increase awareness and visibility of the childcare stabilization grant program with childcare providers, stakeholders, and partners.
