Barriers to Employment for Immigrants and Refugee Families





- Limited English Proficiency.
- Need to be employed quickly but not entering a career pathway- just a job placement.
- Low-literacy in Native language.
- Unfamiliarity with US workplace and culture.
- Post-traumatic stress.
- Lack of High School Diploma or GED.
- Lack of computer and other technology skills.
- Finding enough low cost or free classes, programs, and work experience options.
- Finding staff trained in legal status, documentation, and needs of different immigrant populations.









- Understanding the American workplace culture and recruiting practices and language proficiency
- Recognition of formal academic qualifications or credentials (especially medical profession, engineering) is hard and confusing with multiple Federal, state, and local rules, procedures, etc.
- Differences across States in licensures, depending on where refugees are placed.

Programs are being created to target these refugees and immigrants (such as Northern Virginia Family Service' Training Futures program)

Connecting Refugees to Four Purposes of TANF







- Four purposes of Temporary Assistance to Needy Families:
 - assisting needy families so that children can be cared for in their own homes.
 - reducing the dependency of needy parents by promoting job preparation, work and marriage.
 - preventing out-of-wedlock pregnancies.
 - encouraging the formation and maintenance of two-parent families.
- Needing to connect refugees to healthy marriage and responsible fatherhood programs to strengthen parenting, cultural understanding

Environmental Scan of Programs







Purpose: To document knowledge and research of employment, workforce, career pathways, and adult literacy programs that are reaching refugees and asylees to support technical assistance efforts and knowledge of the field. Three methodological approaches were used:

- 1. Needs Assessment around TANF and Healthcare Challenges and Strengths (2013)
- 2. Literature Review
- Semi-Structured Interviews with ORR Coordinators
