

# Workforce Innovation and Opportunity Act Resources

The Departments of Labor and Education have identified a number of websites for sharing policy, good practice, and technical assistance information during the preparation period for WIOA implementation and the early months of implementation of the statute that began on July 1, 2015.

The Department's Employment and Training Administration posts policy guidance on [www.doleta.gov/wioa](http://www.doleta.gov/wioa). As the graphic indicates, this site is also the main repository for the law, regulations, the Administration's "job-driven vision," "WIOA 101" materials, and important news releases.

The key policy guidance issued during the March – August 2015 period is summarized on the reverse side.

In direct support of WIOA implementation, the **Innovation and Opportunity Network (ION)** represents a community of people, practitioners, partnerships and stakeholders that strive for system capacity building and the continuing excellence of the public workforce system. **QSAPs.** A key early posting on ION has been a set of **Quick Start Action Planners (QSAPs)** These are interactive, self-paced assessment tools to assist leaders at all levels of the public workforce system plan for this transformation and prepare for implementation of WIOA. The QSAP helps identify areas of strength and focused areas for improvement in your workforce system and connect you to targeted resources that can help to prepare and plan effectively. The completion of the five QSAPs (inset box) – and subsequent team discussions to address the results – will be designed to assist states and local areas in developing a common understanding of their readiness to implement WIOA and jointly develop a plan to address opportunities for action.



The WIOA website and the Innovation & Opportunity Network are working in concert to provide you with the most up-to-date information concerning WIOA. This graphic shows what can be found on the two websites and we encourage you to utilize them as a cross-reference tool.

	<b>State Leadership and Governance</b>  The critical role of strategic State Boards in providing leadership and governance for the public workforce system.
	<b>One-Stop Center Service Design</b>  Customer-centered and integrated service delivery through one-stop centers that provide high quality services to job seekers and businesses.
	<b>Youth Services Strategies</b>  Service delivery strategies that emphasize work-based learning opportunities and build career pathways for youth.
	<b>Local Leadership and Governance</b>  The critical role of strategic Local Boards in providing leadership and governance for the public workforce system.


