- Referral from criminal justice partners
- Immediate, Transitional Job
 - Wraparound Services to Address Barriers
 - Child Support Assistance
 - Administrative Review
 - Payment Modifications
- Peer and Community Mentoring
- Education and Training
- Employment Placement and Assistance



RecycleForce Keys to Success


- Do not screen out *anyone* based on perceived lack of readiness
- Put people to work, for wages, immediately
- Increased earnings help people avoid legal trouble

Do not screen out *anyone* based on perceived lack of readiness

- Our Aim: Serve those at higher risk of returning, and least ready for employment
 - Nature of intervention
 - Potential for greatest impact


Put people to work immediately

2017 Linking TANF Families to Employment and Economic Opportunities Meeting Increased earnings help people avoid legal trouble


- \$5,000 in earnings in first 6 months after release, correlated with reduced recidivism*
- Enhanced Transitional Jobs Demonstration
 - Program group had \$3800 more earnings in 1st year
 - Program group had far fewer arrests and convictions in the first six months

Provide broad, employment-centered wraparound services

- All efforts grounded in an employment context
 - Use language of work
 - Virtually no service is off limits, especially those that help promote employment



2017 Linking TANF Families to Employment and Economic Opportunities Meeting Engage program alumni as leaders and mentors

- Peer mentor model developed organically
- Training provided by partner organization
- Primary program enhancement for ETJD study led by MDRC
- Funded in part by a grant from WK Kellogg Foundation between 2015 and 2016



Rely on research to continuously improve

- Participate in random assignment studies
 - Enhanced Transitional Jobs Demonstration
 - REDF studies on social enterprise
- Practice-based evidence
- Continuous quality improvement has led to:
 - Incorporating industry-recognized trainings
 - On-site adult education classes
 - Engaging custodial parents and families (Two-generation Approach)
