	Project HATSA: Guam rolled out Project HATSA (Helping Achieve TANF Success through Action) in January 2012 with a trades-focused career pathway. Now, HATSA is expanding into another career pathway highlighting healthcare. Through these programs, and successful strategic partnerships with employers, community colleges, and local workforce development organizations, Guam has been able to increase the employability and long-term economic outcomes for low- income families. During this peer discussion, representatives from Guam's TANF program will discuss the components of its career pathways initiative and highlight the keys to success.

Community College Career & Technical Training: In June 2013, the Community College Career & Technical Training (C3T) Program launched its initial vocational (non-credit) courses in the field of energy. The C3T Program is a collaborative effort between University of Hawaii Community Colleges (UHCC), the Department of Labor and Industrial Relations, Workforce Development Division (DLIR/WDDI), and the Department of Human Services, Benefit, Employment and Support Services Division (DHS/BESSD) and it provides eligible individuals the necessary basic skills, vocational training, and career pathways that will lead to jobs in three fields—agriculture, energy and health.

Reaching More Students through Linked Learning: Linked Learning is an innovative approach to education in California that integrates rigorous academics with career-based learning and real-world workplace experiences. The U.S. Interagency Council on Homelessness (USICH) has recently partnered with ACF to co-chair an interagency working group to identify ways in which Federal resources including TANF can serve as a critical resource to end family homelessness. Katharine Gale, policy director at USICH, will present on her agency's role in coordinating the effort to end homelessness and then lead a discussion on how TANF agencies can integrate services to address the needs of families at risk of or experiencing homelessness.

	Asset Limit Reform: Recognizing the need to help Hawaii's families build a solid asset base and achieve financial security, during the 2008 Hawaii State Legislature, the Hawaii State Asset Building and Financial Education Task Force was established to develop policy recommendations in the area of asset building and financial literacy. Recommendations from this task force and a further study completed by the Hawaii Department of Human Services in January 2013 recommended the exemption of assets for the TANF program. Governor Neal Abercrombie signed the bill sponsored by the Department into law on April 18, 2013.

	Business Process Reengineering: As part of an effort to streamline operations in its local eligibility offices, Nevada has recently undertaken a Business Process Reengineering project. Three components of the FSSRC will be discussed:
	 Scholar's Network: A network of seven scholars funded by OPRE to conduct family self-sufficiency and stability research.
	 Data Center: A university-based resource available to help state and local TANF agencies access and use administrative and other self-sufficiency data.

 Project AWESOME: A technical assistance resource to improve the ability of State and local TANF agencies to produce and use high quality research.

This session will also be used to elicit feedback from States about challenges and opportunities that may influence their ability to conduct and use research and suggestions for how program administrators may collaborate with researchers to supplement their research capacity and gain insight into the effects of their programming.

	The Behavioral Interventions to Advance Self-Sufficiency (BIAS) project aims to develop and test the application of behavioral economics principles to ACF's programs and target populations. ACF contracted with MDRC and its subcontractor, MEF Associates, to apply a behavioral research lens to programs that serve low-income families, including TANF, child care, child support, and child welfare. Mary Farrell will focus on a pilot she is leading that is designed to increase the number of child support order modifications among incarcerated non-custodial parents in Texas.

	Early Engagement Models: In 2012 there were budget-driven, legislated changes for the California TANF program that included changing the time on aid for work-eligible adults from 48 to 24 months. However, if the adult is meeting Federal work participation requirements their eligibility extends to 48 months. Along with this change of a prospective 24-month time limit, California is implementing new strategies to ensure recipients are receiving appropriate services during their limited time on aid. Todd Bland and Kären Dickerson will discuss early engagement techniques to help prepare TANF families to quickly move into work or work-related activities and increase work participation rates.
