TANF Work Outcomes Measures Comment Timeframes

- [Interim Final Rule](#) (IFR) was published on June 28, 2024
- The first two comment periods (60- and 30-day, sequential) meet the Paperwork Reduction Act (PRA) requirement and lead to OMB approval of the [new report forms](#).
 - The first 60-day comment period ended August 27, 2024.
 - We will let you know when we have revised the forms and the 30-day comment period is open.
- The third (180-day, concurrent) applies to the whole of the IFR. We will modify the IFR and publish a Final Rule if warranted by public comments, which are due by **December 26, 2024**.

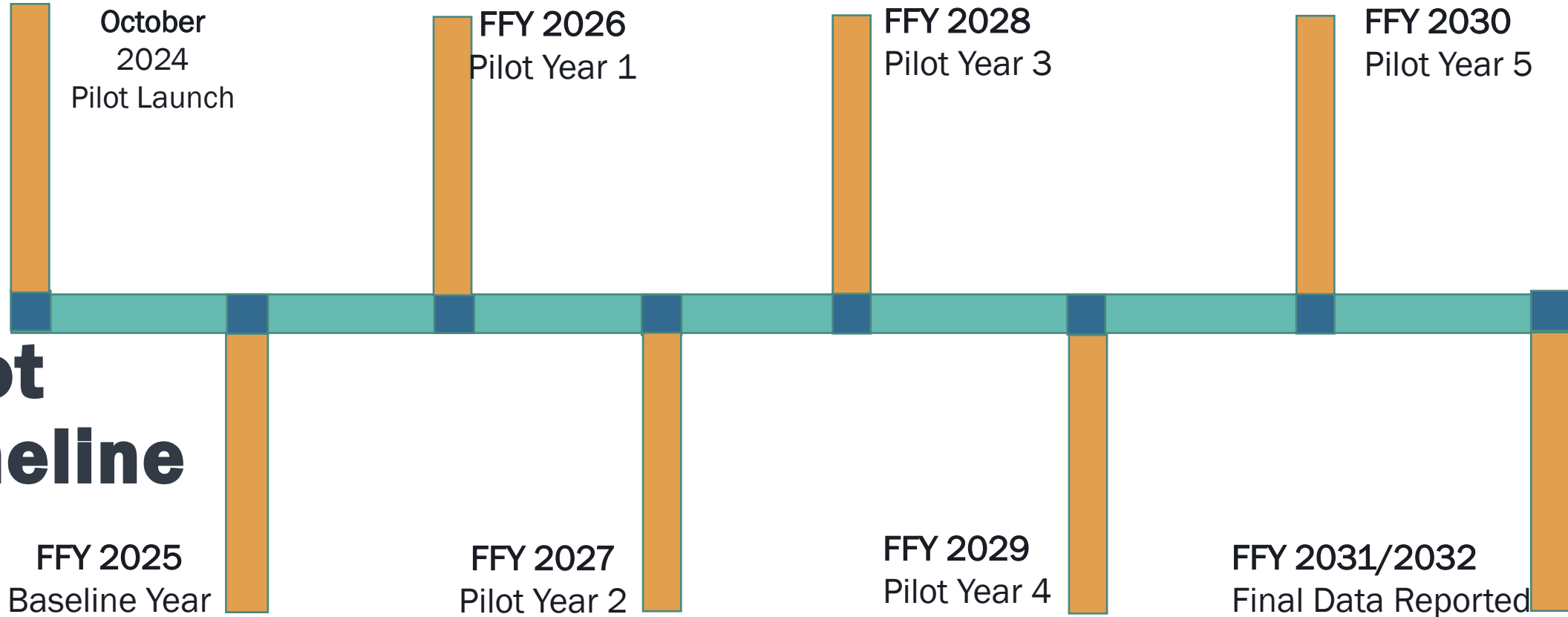

Pilot Timeline

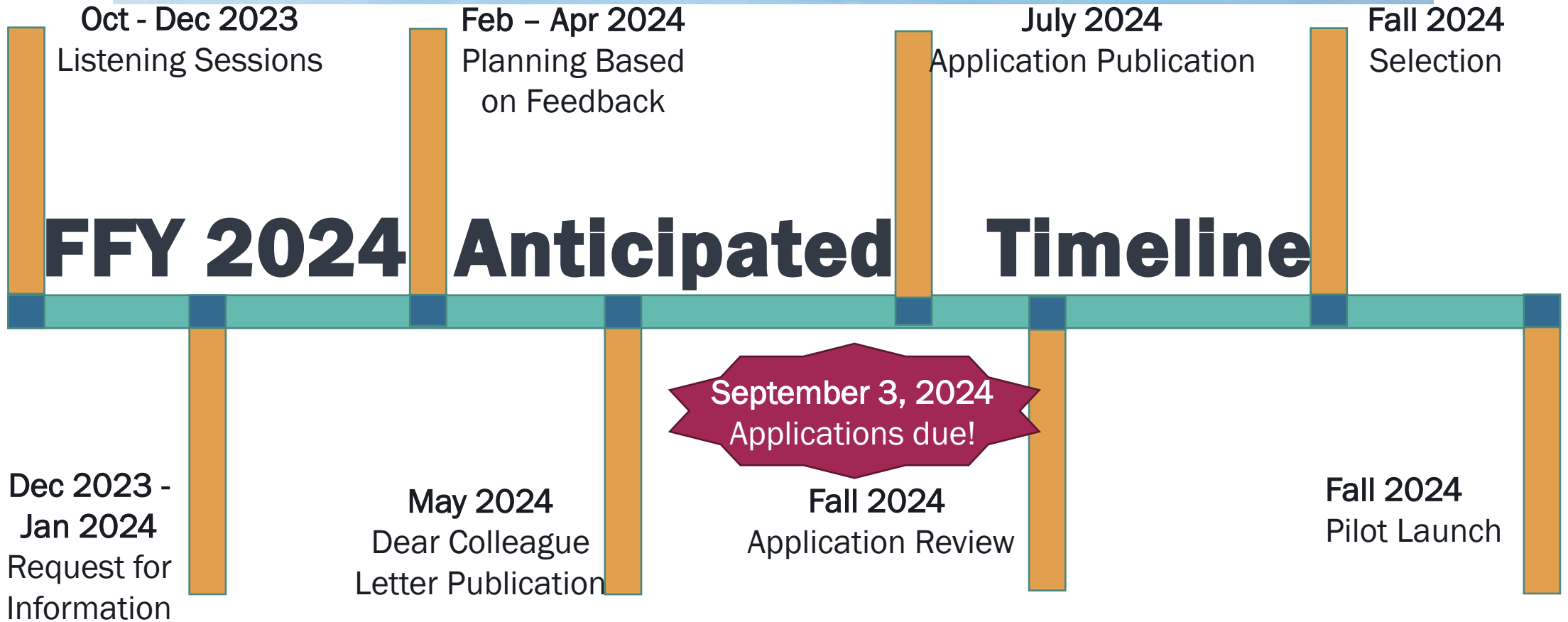
