Reginald Black, *Workforce Development Specialist, D.C. Infrastructure Academy (DCIA), District of Columbia's Department of Employment Services*

She has served on several advisory boards related to improving employment outcomes and ensuring equity for individuals in non-traditional occupations.

Elizabeth (Liza) Ehrlich, *Chief of Workforce Development, NYC Department of Parks and Recreation*

Elizabeth (Liza) Ehrlich is the Chief of Workforce Development for NYC Parks. She joined the agency in 2002 and has dedicated her career there to administering workforce development services and transitional employment programs with a variety of NYC agencies. The largest program and inter-agency partnership is the Parks Opportunity Program (POP), which is jointly administered with the NYC Human Resources Administration/ Department of Social Services and is one of the nation's longest running and largest programs of its kind. In her current role as Chief, Liza designs, implements, and improves upon innovative programming which allows trainees of all ages and backgrounds to perform valuable work for NYC Parks, increasing civic pride and greening city neighborhoods, while pursuing sustainable employment and financial self-sufficiency. Liza has presented on POP and other programs at national and international conferences and is always proud to share strategies to support partner organizations'



efforts in transitioning their clients to self-sufficiency. Liza holds a bachelor's degree in American History and Government from the University of Delaware, and lives in Manhattan.

Appointed by Governor Brown, Dr. Zabin sits on the executive council of the California Workforce Development Board. Before joining the Labor Center, Dr. Zabin was on the faculty at Tulane University and UCLA.
