Common Program Challenges Around Benefits Structure

- Welcome and Introductions
- > Oklahoma:
 - ≥38 Federally Recognized Tribes
 - ➤ 3 have Tribal TANF Programs
 - ➤ Cherokee Nation, Muscogee (Creek) Nation & Osage Nation
 - ≥3 Programs cover 20 of the 77 counties in OK.

TANF Benefit Pro's

- ➤ Assistance to allow Native Children to be cared for in their family homes and strengthen their families
 - ➤ Cash Assistance
 - ➤ Support Services
 - > Incentives
 - ➤ Moral Support/Cheerleaders
 - > Referrals, ex: counseling, treatment, food
 - **≻**Other

TANF Benefit Challenges – Cash Assistance

- > Is the amount sufficient?
 - Compared to a minimum wage job
- ➤ Will the participant complete requirements to receive monthly assistance
 - ➤ Will they receive it in timely manner
 - ➤ Will they receive full amount eligible for



Cherokee Nation Tribal TANF Additional Benefits


- > Incentives for Adults
 - ➤ Educational, Work Participation, 2-Parent Relationship Session
- > Work Participation
 - >\$50 per week Education, volunteer, self-employed, subsidized employment (OJT, WE, etc.), misc. activities
 - >\$100 per week unsubsidized employment
- > Yearly increase to cash assistance payment
- Non-recurring short-term benefits
- > Other

Benefits Cliff

- ➤ Benefits Cliff Gap
 - > Earn too much income to receive other assistance
 - ➤ Child Care, LIHEAP, SNAP, Commodities
 - Or these assistance amounts are reduced
 - ➤ Most times it comes on suddenly
 - ➤ Can and does affect participants' ability to become self-sufficient
 - > ARPA benefits ended
 - **≻**Other

Closing the Gap

- ➤ Cherokee Nation Tribal TANF
 - ➤ Suspension countable income exceeds payment standard
 - ➤ Up to three (3) consecutive months
 - Eligible for all services except monthly cash assistance
 - ➤ Transition countable earned income exceeds payment standard
 - ➤ Up to three (3) consecutive months following suspension
 - ➤ Eligible for all services except monthly cash assistance

Closing the Gap (cont'd)

- > Transition Cont'd
 - Career Specialist begins exit counseling at the start of transition: intense budget counseling, savings review, other resources
 - >Assessments required
 - Final Exit Interview for final review and referrals as needed/requested
 - ➤ Transition Incentive: \$2,500

Closing the Gap (cont'd)

- > Continue to be a moral support
- >Other Ideas
