



Who Can Get Retirement Benefits?

- A person must work to earn Social Security credits.
- In 2014 each \$1,200 in earnings earns one credit.
- You can earn 4 credits in one year.
- You need 40 credits (10 years of work) over your lifetime to qualify for Retirement Benefits.



Who Else Can Get Benefits?

- **Spouses:**
- **Age 62 or older**
- **At any age if caring for a child under age 16 or disabled**
- **Divorced Spouses:**
- **Marriage lasted 10 years & they are unmarried**
- **Unmarried Children:**
- **Up to age 18**
- **Age 18-19 & still in high school**
- **Disabled before the age of 22**

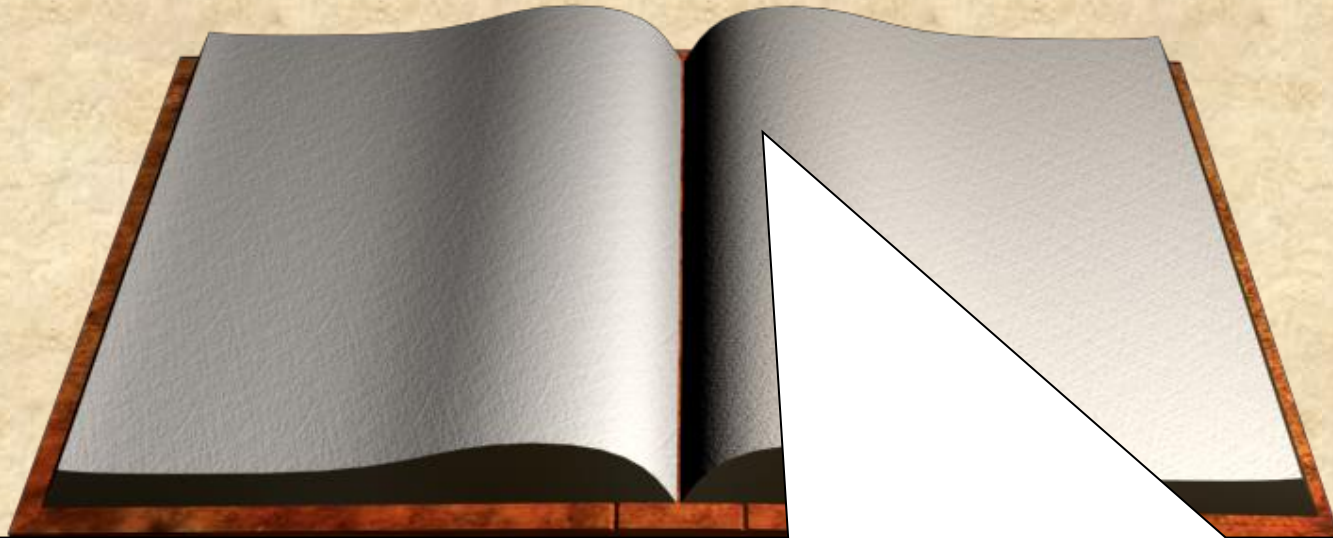

Social Security Definition of Disability



SOCIAL SECURITY'S DISABILITY DEFINITION:

A medical condition preventing substantial work for at least 12 months, or expected to result in death. The determination also considers age, education & work experience.

Who Can Get Disability Benefits?

Worker

- Must have paid into Social Security

Spouse

- Age 62 or older
- At any age if caring for a child under 16 or disabled
- Divorced spouses may qualify

Child

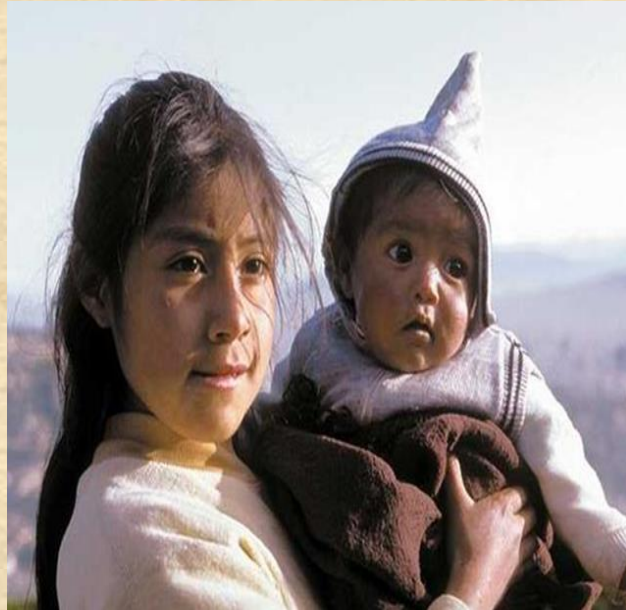


Who Can Get Survivors Benefits?

- **Widows & Widowers**
- **Divorced Widows & Widowers**
- **Children**
- **Dependent Parents**



Who Can Get Grandparent Benefits?



Who Can Receive SSI?

- **Age 65 or older**
- **Blind -- any age**
- **Disabled -- any age**
- **Limited income**
- **Limited resources**
- **Citizen or Qualified Alien**



What Is Considered Income for SSI?

- **Income:** anything received that can be used to meet the needs for food or shelter
- **Earned Income** includes wages, net earnings from self-employment & income received from sheltered workshops
- **Unearned income** includes all other income that is not earned, such as Social Security benefits, Tribal per capita payments, workers or veteran's compensation, support & maintenance in kind, rent & interest



What Are Considered Resources for SSI?

- Resources are cash & things a person owns
- Resource Limits
- Individual - \$2,000
- Couple - \$3,000



Who Can Get Medicare?

- Age 65 or Older
- 24 months after entitlement to Social Security disability
- Amyotrophic Lateral Sclerosis (ALS)
- Permanent kidney failure and receive maintenance dialysis or a kidney transplant
- Exposure to Environmental Health Hazards



When Should you Sign Up for Medicare?

- **Initial – age 65**
- **Special – if still working**
- **General – January – March**



Medicare Has Four Parts

Part A - Hospital Insurance

- No monthly premium for most people.

Part B - Medical Insurance

- Has a monthly premium.

Part C - Medical Insurance

- Health care services through a provider organization

Part D - Medicare Prescription Drug Plan

- Covers a major portion of prescription drug costs
