# Strategies for Identifying and Interrupting the Impact of Trauma on Caseworkers and Managers

In this seminar, participants will first learn the differences between chronic work stress, Secondary Traumatic Stress (STS), compassion fatigue, and burnout. Participants will also learn what emotional labor and secondary resilience mean in practice and will understand how the brain functions after trauma occurs. Resulting from this session, participants will understand the individual, team, and organizational symptoms of trauma, and will be able to identify strategies to intervene at each level of impact (including on individual, team, and organizational levels).
