#### THE CHALLENGE

### The poverty *rate* is lower now than in 1964

- 19% in 1964
- 14.8% in 2014


# But the *number* of people in poverty is higher now than in 1964

- 36.1 million people in 1964
- 46.7 million in 2014

## The child poverty rate is even higher

■ 21% of children in 2014

### TWO GENERATION APPROACHES...


Meet the needs of children and their parents together.

## **ACF SEEKS TO PROMOTE AND SUPPORT**

- Linkages between high-quality early educational services for children and workforce development services for their parents;
- Programmatic efforts to help parents gain the skills, knowledge, and resources to support their child's development;
- Ensuring that families have access to the economic and social supports needed for stability and resilience and healthy child development; and,
- Helping families build social capital that can support both resilience and upward mobility.
- A research agenda that will enhance our understanding of effective two-generation approaches



#### PRESIDENT'S FY 2017 BUDGET PROPOSAL

#### **TANF Two-Generation Demonstration projects:**

- \$100 million for competitive grants to states & tribes
- Coordinated efforts focused simultaneously on parental employment outcomes and child & family well-being outcomes
- Implement strategies & build the evidence base
- Services to low-income families (≤ 200 & of poverty)
- Core components: workforce, early childhood, & social capital development
- \$10 million set aside for research & technical assistance, including development of common performance & outcome measures


## TANF AND TWO-GEN WORKFORCE DEVELOPMENT

- Can the TANF agency partner with Early Head Start / Head Start?
- Can the TANF agency partner with Home Visiting programs?
- Can a TANF client assessment tool include questions about child well-being?
- Can the TANF agency create opportunities for parents of young children to build connections with each other?

Misty started in the CareerAdvance® nursing track with 14 other CAP parents when she had a 3-year old and a 4-year old enrolled at the Disney Early Childhood Education Center.

Her CAP Tulsa Career Coach and Head Start Family Support Specialist supported her at each step. Her community college instructors received training in the Career Advance® model.






