### What is a Learning Disability?

A learning disability in adults is an impairment (physical or mental) that substantially limits one or more major life activities. The Americans with Disability Act of 1990 affords civil rights protection to individuals with disabilities. It guarantees equal opportunity in public accommodations, employment, state and local government services and telecommunications.

Specifically looking how it affects the ability to work and be self-sufficient

#### Benefits

When we allow individuals with learning disabilities equal opportunity in work accommodations we all benefit. We get Citizens with increased purchasing power and heightened selfesteem who have the ability to lead fuller, more productive lives and have a greater sense of independence.

#### Collaboration

- Encourage DSS agencies to share consumer specific information with NCDVRS personnel
- Encourage DSS agencies to include NCDVRS staff in any child and family teams
- Involve NCDVRS in planning and Policy discussions on issues that impact the population that NCDSS serves

Share research of federal and state law and policy for that population being served

#### Partnership with Voc Rehabilitation

- The NCDSS and NCDVRS entered into a MOA effective 5/1/12
- Identified the role of each agency at the State and local level

- Placement Equipment and Tools

#### Assessment continued

- Job Development and Placement
  - Assistive Technology Aids and Devices
- Interpreting Services (American Sign Language & Foreign Languages)
- Transportation
- Maintenance in the support of other rehabilitation services
  - Rehabilitation Engineering
  - Modification to home, vehicle or job site

#### Scenario

**Amy** is a 23 year old mother of 2 who was referred to VR for assessment. Amy was placed in a subsidized position at an Employment and Training Center doing production work. The shelter environment provided supervision in a controlled environment. Amy was successful in the placement and eventually went on to full time employment at a local manufacturing company.
