so you can be excused from:**

- Work requirements**
- Child support cooperation requirements**
- Requirement for teen parent to live at home**
- Time limits**
- Some other requirements with approval**

Your Income Maintenance Caseworker can excuse you from some of the welfare requirements and provide names and telephone numbers of local agencies that can help.

When You Open a Child Support Case:

The court will establish an order for financial and medical support, as well as custody and visitation.

You will have to appear in court with the other parent or participate in a negotiation meeting at a child support office.

Your physical address will be printed on child support documents and could be accessed by the other parent.

There Are Steps You Can Take To Protect Yourself And Your Children.

Tell child support staff about your safety concerns.

Ask child support staff about safety measures that can be in place for your court date.

Ask about family violence protections and keeping your address confidential.

APPLYING FOR CHILD SUPPORT IS A REQUIREMENT OF TANF

When you open a child support case:

The court will establish financial and medical support, as well as custody and visitation.

You will have to appear in court with the other parent or participate in a negotiation meeting at a child support office.

Your physical address will be printed on child support documents.

If you have concerns that these things may put you and your children in danger,
YOU HAVE OPTIONS.

1

Ask your TANF case worker/Texas Works advisor about GOOD CAUSE.

This waives the requirement of child support cooperation and allows you to receive TANF without applying for child support if doing so would place you or your children in danger.

2

If you choose to apply for child support, ask child support office staff about FAMILY VIOLENCE PROTECTIONS.

The Office of the Attorney General can protect your address and take other safety measures throughout the child support process.
