

**PE SCREENING QUESTIONS FOR RANDOM ASSIGNMENT<sup>1</sup> - 03/12/07**

1. Are you currently employed? *Participant must be employed to be eligible.*
2. Are you currently receiving CalWORKs cash aid?  
*If the answer is Yes, do not go further; participants are not eligible if currently receiving CALWORKS cash aid.*
3. Are you working legally in the U.S. at \$15.00 an hour or less? *If earning over \$15 an hour – not eligible.*
4. Are you between the age of 18 and 62? *If over 62 years of age, participants are not eligible.*
5. Are any other members of your household in Project EARN or have they gone through Random Assignment for Project EARN? *(Only one member per household may go through random assignment)*
6. **Men only** : Did you register for Selective Service? *Men born after 12/31/59 must have registered. Non-citizens males must also have registered. If he became a resident of the US after age 26 he's exempt; tell him will need to bring in his Permanent Resident or Alien Registration card to verify the date of residency if he is assigned to PE. If participant is age 18-25, you can have him register on line before doing RA.*

7. Where do you currently live? *Participants preferably live in one of the following zip codes:*

8. If you are selected to participate in the program we will need proof of your residency. Will you be able to provide proof that you live in San Diego County? This could be in the form of a rent check, utility bill in your name or mail addressed to you at your home.  
*Answering **No** to this question does not eliminate applicant from being randomly assigned.*

<sup>1</sup> Project EARN staff will rely on self-reported information to determine eligibility for random assignment. Written verification of this information will be required when eligibility is determined for WIA and work support programs.

<sup>2</sup> Use this number to determine family size when using the 2006 Federal Poverty Guideline chart.

Use the following income chart to determine income eligibility for the appropriate family size. All forms of income should count for the purposes of determining eligibility, including earnings, child support, and any public cash assistance other than TANF (e.g., SSA or SDI). Do not count wages of a minor child (younger than **19** years old), but do count income such as SSI payments.

To calculate gross monthly income from weekly earnings, take the number of hours worked per week, multiply this by the wage per hour. Then take the total and multiple by 4.33. Use the column 3 to see if the participant's income is within the threshold level for his/her family size. If the prospective client has more than 1 job or his or her spouse has a job, you'll have to add the income from these jobs to the income from the first job.

*If the participant is not income eligible based on this table, ask the following questions:*

A. Within the past 2 years, have you been laid-off and are you unlikely to return to your previous industry or occupation? (Check qualifying industry lists)

B. Within the past 2 years, have you been laid-off as part of a plant closure or other mass layoff? (If the participant has received notification of a lay-off, but is still working at that job, this would not count as a layoff)

C. Within the past 2 years, have you been self employed, but then suffered a business failure because of local economic conditions or a natural disaster?

D. Within the past 2 years, have you been a displaced homemaker? (A displaced homemaker is someone who was dependent on the income of a family member, but that income is no longer available)

E. Within the past 2 years, have you been certified as a dislocated worker or enrolled in a dislocated worker program?

*If the answer is Yes to any one of the questions above (A-E), use the following chart to determine income eligibility:*
